Review

Group invoiced sales Increased by 7.3%, to €24.9 mio (€23.2 mio in 2012).

Net profit after tax and minority rights increased to € 321,000 (losses € -2.0 mio in 2012).

Group Solvency (Equity as a percentage of Total Liabilities without Cash and Securities) as at 30 June 2013 was 48.3%.
