Announcement of results

The Group's sales reached €171.0m, recording an increase of 1,7% compared to €168.1m in 30.09.2024. Gross profits reached 21.3% (20.6% in 30.09.2024). Earnings after income tax increased by 6.7% and reached €6.4m (€6.0m in 30.09.2024).

The Group's capital adequacy ratio (equity as a percentage of total assets without cash and cash equivalents) was 48.8% on 30.09.2025.
